## Headley Court Outline Planning Application

*Drop In Session at The Village Hall – Wednesday 26<sup>th</sup> February*

The first planning application covering the proposed development at Headley Court has been submitted to Mole Valley. It is an outline application for up to 100 houses on the land to the West of the road to Leatherhead. The details of the application are broadly in line with the plans shown by Angle Property at their consultation session in November.

Cllrs Coe, Furr, Preedy and Steventon have formed a Working Group to prepare the Parish Council's own formal submission, but we also encourage residents to make their own submissions.



In order to capture as many local views as possible to inform the Parish Council's submission we are organising the following:

- As soon as the detailed plans are publicly available, we will publicise the link on our web-site and to our e-newsletter subscribers;
- We are organising a drop-in session at the Village Hall on February 26<sup>th</sup> from 3.30pm to 8pm; we will have copies of the key plans and a summary of the key concerns we have identified about the proposals. Parish councillors will be present to discuss these and to listen to other issues that you might raise. We will also be able to provide help on how to make your own submissions.
- We have scheduled a special Parish Council meeting on 9<sup>th</sup> March from 7:30pm-9pm. This will review two items – the PC submission on the Headley Court application, and our proposed response to the Draft Local Plan consultation.

## SES Water Mains Update

The Parish Council has been in regular communications with SES Water about the progress of works along Church Lane to replace the water mains. The work is scheduled to last until Summer 2020.

Following complaints from the Parish Council we have seen some improvements:

- The information on the SES Water website has been updated, including details of the alternative bus provision;
- Signage about the businesses being open has been improved;
- SES Water has agreed to a regular meeting with Cllrs Furr and Laverty so we are kept fully briefed on progress;
- We have been promised better liaison before plans are finalised for subsequent works on Headley Common Road.



Meanwhile, Cllr Preedy is in discussions with SES Water's senior management to explain the massive disruption this work is causing to our community and to ask them to allocate more priority and resources to the project. He is also asking for a more flexible approach to providing compensation to small local business for the impact of the closure.

## New Headley Parish Council Website

The Parish Council has launched a new website which went live at the end of January. We had to transfer to a new vendor since the previous site was no longer supported. The web-site address is unchanged at [www.headley-pc.gov.uk](http://www.headley-pc.gov.uk), but the move enables us to keep it more up-to-date as a source of information about the Parish Council and other issues affecting the community.

The new website gives us the chance to revive our e-newsletters in a way that meets the GDPR privacy regulations. ## Church Lane Nursery Update

We are expecting a planning application to be submitted for the Church Lane Nursery site. For over 8 years the Parish Council has been in discussions with the site owners and their agents with a view to building some affordable homes for people with a connection to Headley. The site has been viewed as the most appropriate site in walking distance of the centre of the village.

In 2019, based on feedback from residents, the Parish Council informed the owners that their plans were too intensive for the site. The owners have proposed some modest changes, but the Parish Council has felt unable to support them. If a new application is submitted to Mole Valley, we will organise another drop-in session before deciding whether to give them the Parish Council's backing.

## Mole Valley Draft Local Plan

- Are we building the right sort of homes in the right places in Mole Valley?
- Is there enough affordable housing and housing to rent?
- What sort of infrastructure is needed to support new housing?
- Are we protecting our Green Belt and open spaces?
- Are we doing enough to combat climate change?

These are just of the issues that will be affected by Mole Valley's next Local Plan. This will set the policy framework for planning decisions in the District up until 2033 and identifies potential sites for enough new homes to meet the Government-imposed target of new homes for Mole Valley. While the bulk of the demand would be met from brownfield sites, some of the proposed sites are in the Green Belt.

The Draft Local Plan is now available for public consultation until 23<sup>rd</sup> March.

The key headlines directly affecting Headley are:

- The entire village would remain "washed over" by the Green Belt; this provides a high-level of protection against inappropriate development
- There is an update describing Headley Court as a developed site within the Green Belt; this may well be overtaken by events if the current planning application is progressed;
- The rumoured housing site near Highlands Farm is not one of the sites proposed for housing.

This is a really important document for the future of our area and the Parish Council will be preparing a submission; this will be reviewed at the special Council Meeting on Monday 9<sup>th</sup> March – please join us from 7.30pm at The Village Hall.

We also strongly suggest residents reply directly to the consultation. Every household will be sent a card describing the process. The information is available online at [futuremolevalley.org](http://futuremolevalley.org) or paper copies can be supplied on request. There are also 13 consultation events across the District where Council officers will be on hand to answer your questions.
